Dedes terms & conditions

Beverages - cannot be purchased or transported from the main bar to the dining room. All beverage service is provided by table service within the dining room hence payment as you go is not accepted. An honour system can be arranged with a price list and basket for monies to be contributed individually as you go. Pre-ordered wines and beverages can be arranged, as well as bar limits and restrictions.

Cakes - an in-house selection of cakes is available as a dessert option for the 3 course menu with 48 hours notice to Dedes, please see our Cake List for further details. Please note that cakes from external providers are not permitted to be in the restaurant.

Catering - Dedes Restaurant, exclusively deals with all catering needs for the Sydney Rowing Club. No outside catering is permitted within the club or any part of the grounds.

Cancellations - Any cancellation must be made in writing to Dedes Restaurant.

Arrivals - if on the day of your booking you are running more than 15 minutes late, we request to be notified as this may also result in delay of food service.

Table setup - Dedes will not be held responsible for the set up of table's other than linen, glassware and crockery. All other request such as centerpieces and name tags on tables can be placed by the guest.

Table Allocation - all table allocation requests will be taken into consideration, however set ups will be left to the discretion of the restaurant host.

Deposits - A deposit of \$200.00 is required to secure a group booking which is non refundable if the booking is cancelled within 7 days of the Booking Date.

Dedes Group at all times practices & adheres to the Responsible Service of Alcohol guidelines; the Registered Clubs Act and the Liquor Act.

Dining Hours:

- Lunch - Wednesday to Sunday from 12.00 noon.
- Dinner - Wednesday to Saturday from 6.00pm.

Entry to Club premises - To hold a Group Booking within the Sydney Rowing Club, it is a good idea that one of the organisers be a club member (social membership is available for a charge of \$20.00 for the year). All persons entering club premises are covered by the Registered Clubs Act and are required to abide by all the rules and regulations therein. The organiser/member for the function will be responsible for their guests while on the premises and grounds of the club.

Gratuities - A gratuity of 7% is levied on all group bookings.

Final Numbers - are required 3 days prior to the Booking Date and will be the minimum number of guests you are charged for.

Group Bookings - A Group Booking is a reservation for 50 or less people in the dining room. Reservations over 50 people are considered a private function and hence require a function room. Group bookings of 15 or more people are required to order from a set menu. Copies of the set menus are shown overleaf.

GST - Prices are inclusive of GST.

Payment details - a full itemised food and beverage account will be provided upon completion of your function - note that separate accounts will not be given. Full payment is required by way of cash, Eftpos, MasterCard, Visa, Diners or American Express. Cheques will not be accepted on the Booking Date.

Prices/Menus - Dedes Restaurant reserves the right to change prices, menus and/or ingredients for menu dishes at anytime without prior notice. All prices and menus will be confirmed once a Group Booking has been made and deposit paid.

Public holiday surcharge - a surcharge of \$5 per person applies to all Group Bookings which fall on a public holiday.
